

**Teamsters Local 135 Bass Tournament Rule & Regulations**  
April 14, 2012 at Patoka Lake (Spring Tournament)  
September 8, 2012 at Patoka Lake (Fall Tournament)

1. Cost **\$40.00** per team. **60** Boat maximum for Spring and Fall.
2. Entry Deadline: As specified on each entry form. **NO LATE ENTRIES.**
3. Pay back will pay 1<sup>st</sup>-10<sup>th</sup> positions. 100% less expenses, one place for every 10 boats, **based on 100-boat entry.**
4. One member of team must be a **Teamster** member.
5. Safety: Each contestant is to wear a Coast Guard approved life preserver when gas motor is running.
6. Sportsmanship: All contestants are to show courtesy to all other contestants. No fishing 50 yards of another contestant's boat or 100 yards of the launching ramp.
7. Scoring: Only large mouth, small mouth, Kentucky bass will be weighed. Limit shall be 6 fish per team. All bass must be 15 inches or more in length (including small mouth). **There will be a 1lb. Penalty for each short fish. Absolutely no dead fish will be weighed.**
8. Off limits: Lake(s) are off limits at 5:00PM evening before tournament till tournament launch.
9. Take off: Positions will be in the order of entries received. **NO REFUNDS.**
10. Live-wells will be checked on the ramp starting at 4:30AM. All live wells must be aerated and operable.
11. Pre-Tournament meeting will be held on the water at 5:45AM.
12. Weigh-in: There will be a 1lb. Penalty for each minute you are late at the check in boat. More than fifteen minutes late, your entire catch will be disqualified.
13. Weigh in scales will not open until 1:00PM. Once you come to the scales, you will not be permitted to go back out to fish.
14. Tie: In case of a tie, the two places that are involved will divide the money for those two places.
15. Big Bass: Optional **\$10.00** per team – 100% pay back. May be paid with entry fee.
16. Protest: Any protest must be filed in writing within 15 minutes after weigh-in. Interpretation of these rules shall be left exclusively to the tournament committee. The decision of the tournament committee shall be final in all matters.
17. No live bait. Artificial bait only. No trolling. Fishing and (or) landing fish must be done from your boat.
18. If Department of Natural Resources (DNR) issues any member of your team a citation, that is an automatic disqualification from Big Bass and Team Bass Tournament(s). Any team violating these rules or any Indiana Boating and Fishing rules will be disqualified.
19. Liability Release: In signing this agreement, I hereby release Teamsters Local 135, its officers, agents, employees, members, and sponsors from any and all damages, claims, demands, costs or expenses relating to any property which I may sustain or which I may cause by reason of participating in or in connection with these tournaments.
